


- 35% increase in number of wells monitored with 10 acoustic measurement devices installed for constant, real-time measurement of water levels.
- \$20,000 awarded to all 18 Fire Departments in Burleson & Milam Co. for foam and foam dispersing ProPaks reducing the water needed to extinguish fires by 50-90%!

RAINWATER HARVESTING

In September of 2017, Post Oak Savannah Groundwater Conservation District (POSGCD) and Texas A&M AgriLife Extension Service (AgriLife) collaborated to offer a Water Conservation Program through the District. The program includes: a rainwater harvesting system, rainwater harvesting rebate program, drought-tolerant garden and irrigation demonstration sites, and series of educational workshops.



- 13 Rainwater Harvesting Systems were installed with grant funding that results in reduces pumping demands, erosion, and storm water runoff for our aquifers by 51,500 gallons through capture.
- \$1,254,150 in grants were awarded to local water utilities to replace damaged water lines to reduce water lost to leakage and increase water quality.



- POSGCD received a Clean Financial Audit, the highest score available, for the last year.
- State Auditors Office of Texas for Groundwater
 Districts revealed POSGCD a perfect score with Fully
 Compliance in all nine Texas Water Code requirements audited.





Shake to Start!
