1. Call to order

2. Consider, Discuss and Score 2024 Groundwater Conservation Grant Awards

The committee again reviewed and discussed the intent of the Groundwater Conservation Grant program and the scoring system used. It was noted that the currently budgeted amount for 2024 is \$1,300,000.

The committee then discussed the previous efforts of scoring of the 10 individual applications totaling \$2,317,187 at the April 19, 2024 Grant Committee Meeting. After deliberation the committee agreed the application filed by Cooks Point WSC should be removed from consideration as the project would replace the project applied for and awarded the previous year which had been successful. The committee further discussed the available funding and scores of each application, as well as options for award. A motion was made by Director Redington and seconded by Chairman Wilder to recommend to the Board the award of the following applications at 90% of the originally requested amounts, which would result in the following awards and adjusted amounts, and amend the 2024 District Budget accordingly:

City of Snook	<u>\$171,270</u>	Replace Obsolete Water Lines and valves, tie in lines
